
# Support for Museum Collaborations



## application closed

#### For whom and for what?

This scheme is intended for museums as a grant for joint initiatives that go beyond the usual collaboration; that strengthen the relationship between the public at large and cultural heritage; that are of a lasting nature, set an example and can be imitated by others and which ultimately result in a stronger museum sector. It concerns the following areas:

- education
- audience reach
- profile
- science
- digital options
- collection policy

Grants may also be used for studies investigating the feasibility of forms of collaboration including preparing far-reaching forms of cooperation or mergers; specific expertise which leads to closer collaboration in the aforementioned areas, best practices studies, setting up intensive international collaboration.

The aim is to encourage special and lasting partnerships between museums, which may or

maximum grant amount awarded by the Mondriaan Fund is 40 percent of the project costs and 70 percent of the costs of a feasibility study.

## Conditions

In addition to the General Terms and Conditions, the Support for Museum Collaborations is

- Museums Register or are members of the Museums Association (Museumvereniging), in association with one or more other museums located in the Netherlands or abroad, and/or a social partner (e.g. education institute, health care institution, fellow cultural institution, the business community or the public at large). Organisations representing several museums at once are free to apply for a grant, as well. Grants may be used for partnerships that jointly seek to achieve at least one of the following objectives: attracting more people and/or new people; raising the profile of the collection;
- ensuring that museum staff's knowledge is shared or safeguarded; making museums more profitable by means of cost savings or an increase in turnover. ■ The budget for the project must exceed €25,000. The Mondriaan Fund's grant will cover up to 40 percent of the project costs. Applications are more likely to be successful if the
- applicant is able to fund part of the project itself due to a successful crowd-funding campaign. When it comes to feasibility studies, the Mondriaan Fund's grant will not exceed €15,000. The Fund's grant will cover up to 70 percent of the total project costs. Plans for major
- partnerships are eligible for substantial financial support. Collections must be disposed of in accordance with the Guideline for the Disposal of Museum Objects and, where possible, according to the valuation framework of the Dutch Cultural Heritage Agency.
- A request for collaboration must include a jointly drawn-up plan featuring the following aspects: an explanation on how the applicant intends to safeguard and share its knowledge and experience with the museum community; a presentation plan; a budget, preferably including quotations; and, where applicable, pledges by parties who are participating in the project or have invited others to do so. Applications relating to the reallocation and/or disposal of collections must include collection plans by both the museum receiving the

The advisory committee will assess the applications for their significance to Dutch cultural heritage, contemporary visual arts and the Dutch public. The following documents will be considered in the assessment: A jointly drawn-up plan explaining how the applicant intends to safeguard and share its

knowledge and experience with the museum community; Where applicable, a presentation plan explaining how the applicant intends to attract and retain the right audience; A budget, preferably with quotations;

- Where applicable, pledges by parties who are participating in the project or have invited others to do so. Applications relating to the reallocation or disposal of collections must include collection
- plans by both the museum receiving the collection and the museum disposing of the collection.

In assessing the applications, the advisory committee will consider the following interrelated

criteria: Whether the submitted plan sets a convincing example or is otherwise special; Whether the quality of the position of the institutions concerned is important to Dutch

Whether the partnership is likely to result in improved quality and/or cost savings, and

• Whether the museum community will benefit from the parties' new-found knowledge, thus

 Whether the plan will increase diversity and promote the spread of art across the various regions (where applicable).

Applicants are only eligible for Support for Museum Collaborations if the advisory committee

issues a positive recommendation on the application. Such a positive recommendation may come with a recommendation on the sum to be awarded as a grant. For budgetary reasons, the

Whether the plan will raise the collection's profile (where applicable);

Mondriaan Fund's board may request the advisory committee to weigh the applications against each other and rank positive recommendations in order of priority. Apply

Applications for Support for Museum Collaborations can be submitted through the Mondriaan

Fund's online application system, for which you need an account. With your account you can

access the application form, where you can fill in the questions and upload the information

requested in the checklist below. Click here for the FAQ about online applications.

The deadline for submitting applications for Museum Collaborations is 12 October 2020, before 5 p.m. Applicants must allow for a total processing period of a maximum of three months from the moment the application is completed. Grants from the Mondriaan Fund cannot be awarded with retroactive effect, which is why the application must be submitted well before the desired starting date.
