The deadline for the Artist in Residency Grants for residencies in the Netherlands is 31 August 2020. The deadlines for residencies abroad are postponed for the time being. As soon as these grants can be offered again, we will announce it on the website. For whom and for what?

An application for an Artist-in-Residency Grant can be submitted by visual artists and

intermediaries who wish to spend some time at a studio selected by the Mondriaan Fund, either in the Netherlands or abroad. Most of these Artist-in-Residency are linked to national and international initiatives and programmes for artists and intermediaries from all over the world. The grant must be used to pay for travel, housing and material expenses. The rent for the studio and/or living space will be paid directly by the Mondriaan Fund. The aim is to promote the artist's or intermediary's development as an artist and professional

practice while he/she is working abroad or in different surroundings. In this way, applicants can explore, expand and build up new national and international contacts, networks and markets. Applications for some guest studios can only be made by either visual artists or intermediaries, while other studios can be applied for by both visual artists and

intermediaries. The explanations include specific information for each studio about the nature of the residency, the conditions, the duration of stay, the size of the grant, the deadlines for the application rounds, etc. An application for an Artist-in-Residency Grant can also be submitted jointly with another artist or intermediary. For the purposes of the grant application, a 'duo' is defined as two

artists or an artist and an intermediary who regularly create work together. Partnerships can

be regarded as (one-off) duos if the partners submit a joint plan for the work period that will lead to a single result. For applications made by duos or partnerships, each party must fill in a separate form. Some studios are not intended for duos. This is indicated for the relevant studios. **Conditions** In addition to the General Terms and Conditions, Artist-in-Residency Grants are subject to the following conditions:

Applications can only be submitted by artists who have been working professionally as

curriculum at a university of the arts and have worked as professional artists for at least one year since then. Intermediaries applying for a grant must have been working professionally as an

intermediary in the visual arts or cultural heritage sector for at least two years. They must

projects. • To be eligible for a grant, the artist or intermediary must be professionally active as a visual artist and/or in the cultural heritage sector and must be integrated in that capacity into the Dutch professional visual art and/or cultural heritage community. • Applications for an Artist-in-Residency Grant cannot be submitted if the applicant is taking

a Bachelor's degree at a school inside or outside the Netherlands.

• Applications for an Artist-in-Residency Grant can be submitted if the applicants are in the final year of their Master's degree, or a degree from a post-academic institution such as the National Academy (Rijksakademie), BAK, the Ateliers, the Jan van Eyck Academy, or Sundaymorning@EKWC; and if the residency period doesn't coincide with the work period at

• During one round of applications, visual artists or intermediaries can submit an application

for a maximum of two studios. For each studio, a separate form with annexes must be

submitted, and the applicant must indicate his/her preference for one of the two studios. • The applicant is expected to raise at least 10 percent of the required funds himself/herself. This personal contribution must relate to the amount that the Mondriaan Fund will make available for the duration of the stay. Applicants may use their own money, or alternatively, funds obtained from third parties, an interest-free loan from the Kwadraat Fund or funds raised through a crowd-funding campaign. The grant application is more likely to be

successful if the applicant has raised some funds itself by means of a crowd-funding

All applications that comply with the formal conditions and that include all the requested annexes will be presented to an advisory committee that will issue recommendations on the allocation of a grant for the relevant studio. The advisory committee will assess the importance, quality and development of the applicant's work, the quality of the plan, and its compatibility with the institution or the course

programme at which the applicant seeks to implement the plan. It will do so on the basis of:

The applicant's CV (resume); Information about the work and the artistic or intellectual principles;

<u>Assessment</u>

 A presentation plan that explains how the project or work that will come about during and after the work period will be displayed to an appropriate audience in an inspiring way. The advisory committee will assess whether the applicant's plans for the stay at the guest studio in question will make a meaningful contribution to visual art in the Netherlands. The

selection procedure for the Artist-in-Residency Grant will be subject to a 'drop-out procedure'.

In all cases, the committee will first issue a recommendation on the applicant's artistic

The advisory committee will use the following interrelated criteria to assess the artist's or intermediary's artistic performance:

Artist: the question as to whether the oeuvre created by the artist up to the moment of the

grant application is important – or, in the case of a beginner artist, is expected to become important – to contemporary visual art in the Netherlands. This assessment is primarily focussed on the connection between the artist's artistic principles and the way in which these are expressed in his or her work. Among other things, the committee may examine the intellectual meaning of the concept, the artist's power of imagination and his/her mastery of the chosen materials. Furthermore, the committee will examine how the artist's work and opinions relate to the historical and current context. Intermediary: the question as to whether the oeuvre created by the intermediary up to the moment of the grant application is important to contemporary visual art or cultural heritage in the Netherlands, or is expected to become so. This assessment is primarily focussed on

the connection between the intermediary's intellectual and/or theoretical position and on

how this is expressed in his/her work. Among other things, the committee will examine the

meaning and significance of the intermediary's vision, the ambition it reflects and how this

vision relates to the historical and current context and to the how this is perceived.

In addition to the quality of the previously realised work, the committee's expectations for the

committee therefore attaches great importance to the artist or intermediary's plans and reasons for the application. Applicants must clearly explain how they want to use the grant, what plans they have for new work or research, and how they believe the work period will contribute to their artistic development and how it will help them build up a new network. The advisory committee will assess this on the basis of: • The intellectual quality of the work plan, with the work plan also being assessed in the context of the studio for which the application was submitted. Does the work plan fit in with the studio's programme and can it be realised at that location? Is the advisory committee confident that the work period at this studio will contribute to the quality of the applicant's

• The presentation plan, particularly the way it is aimed at reaching an appropriate audience

Applications for the Artist-in-Residency Grant will be assessed by an alternating pool of committee members. The procedure can differ for each studio, but in most cases an advisory committee made up by representatives of the Mondriaan Fund will compile a shortlist of nominees from which the managers of the studios concerned will ultimately make a selection. In some cases, a representative of the guest studio will sit on the selection committee.

Applicants are only eligible for an Artist-in-Residency Grant if the advisory committee issues a

positive recommendation regarding the above interrelated criteria. After the final round of

applications, the advisory committee may propose its own candidates.
